### Executive summary

This report is to consider a late request for financial assistance under Council's Financial Assistance Policy.

### Detailed report

Provision is made in Council's Financial Assistance Policy for community not for profit organisations, groups and individuals which offer a significant contribution to the social, economic and/or environmental well-being of the Community.

#### GULGONG MEMORIAL HALL COMMITTEE - GULGONG CHRISTMAS CELEBRATION

The Gulgong Memorial Hall Committee has requested \$3500 funding for this year's Christmas Celebration, a community event for Gulgong. This event is aimed at children, with Carnival rides and other activities, and is the only venue in Gulgong where children can have their photos taken with Santa. It is to be held on the 12th of December from 5 to 9 pm.

Council staff recommend that this event be granted \$3,000 financial support, waiving of the Gulgong Memorial Hall hire fee for a half day at \$58, and waiving of the collection of bond for this facility. This would be in-line with previous years' financial assistance.

Link to Community Plan: Strategy 1.4.2. Support arts and cultural development across the Region.

### Financial and Operational Plan implications

Funding of \$148,000 is provided in the 2015/16 Operational Plan for Financial Assistance. \$86,804 has been allocated, leaving a balance of \$61,196. Should Council approve the September quarter financial assistance applications as recommended, it will leave a balance of \$24,200. Should Council approve the additional request for support for the Nightrider bus in Gulgong, it will leave a balance of \$19,200.

Should Council approve the recommendations in this report, a balance of \$16,142 will then remain in the Financial Assistance Program.
