### **Matters in Progress**

Matters in Progress discussed and updated as below

There were no outstanding items from the previous meeting.

#### Correspondence

Correspondence from the Lions Club regarding the proposed ticket box to be constructed adjacent to the main gates on Douro Street was distributed to members prior to the meeting seeking approval for the ticket box and emails were received from most members approving the position and design. Planning staff have confirmed that a DA is not required and the Lions Club have been informed that the proposal is approved and they are currently seeking funding.

## **Financial Report**

Financial results were discussed and noted that both income and expenditure are tracking to be on budget for year end.

### **General Business**

- New amenities building will consist of toilets, showers and laundry with an outdoor camp kitchen facing the main arena and will be primarily for campers and will be located parallel with the current Bridge Club building.
- Weed spraying there are patches of weeds that will need to be sprayed on the footpath around the complex and also near the dressage area and stables. This will be discussed with Council's weeds staff.



- Pigeons again becoming a problem Bill will discuss with Jamie
- Starters stand the old metal starters stand near the dressage area that is not used is now a play area for children and deemed unsafe. Original owner of the stand is not known and this will be removed at the end of February unless otherwise advised prior to that date.
- Fees and Charges the fees and charges will generally raise by CPI and additionally individual buildings will have electricity meters installed and each building "owner" will be charged for their electricity usage from July 2019.
- Douro Rd roadworks there will be road works commencing in the coming months in the area near the main gate and some works will also be done on the verges.
- Mudgee Show during the preparations for the upcoming show the gates will be allowed to remain open during the day, still closed at night, to assist with traffic movement as the kangaroos seem to have moved on.
- Horse manure the horse manure is spreading onto the road near the stables. If this
  continues new signage will be installed, noting the previous signage mysteriously
  disappeared.
- RDA will be constructing a shed near the current amenities building for their use.
